FUNDED PROGRAMS ARE ACCOUNTABLE THROUGH MONTHLY OR QUARTERLY FINANCIAL REIMBURSEMENT REQUESTS AND REPORTS, WHICH INCLUDE SUPPORTING DOCUMENTATION FOR EXPENDITURES, AND THE NMCL APPROVES PROGRAM BUDGETS. FUNDED PROGRAMS SUBMIT MID AND YEAR-END PROGRAM PROJECT PROGRESS REPORTS WHICH INCLUDE THE DEMOGRAPHICS OF TUTORS AND STUDENTS, STUDENT STATUS AT IN-TAKE, AND STUDENT GOAL ATTAINMENT. THE NMCL ALSO CONDUCTS SITE VISITS TO FUNDED PROGRAMS AND PROVIDES TECHNICAL ASSISTANCE AS NEEDED TO ENSURE COMPLIANCE AND PROVIDE SUPPORT.
