

**ARTICLES OF INCORPORATION  
OF  
NEW MEXICO COALITION FOR LITERACY**

**A Nonprofit Corporation**

I, the undersigned, a natural person of the age of eighteen years, or more, acting as an incorporator of a corporation under the Nonprofit Corporation Act of the State of New Mexico, do hereby adopt the following Articles of Incorporation for such Corporation.

**FIRST:** The name of the Corporation is:

**NEW MEXICO COALITION FOR LITERACY**

**SECOND:** The term of the Corporation shall be perpetual.

**THIRD:** The purpose of the Corporation is to coordinate, assist, improve and enlarge the delivery and expansion of educational services relating to literacy training for adults.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code.

**FOURTH:** Provisions for the regulations of the internal affairs of the corporation, including provisions for the distribution of assets on dissolution or final liquidation, are:

- a. All liabilities and obligations of the Corpo-

ration shall be paid, satisfied, and distributed, or adequate provision shall be made therefore.

b. None of the remaining assets shall inure to any individual, but shall be distributed only to a fund or foundation or corporation whose property is likewise irrevocably dedicated to the purposes stated in Paragraph "THIRD" as required by the Internal Revenue Code of the United States.




